RESOLUTIONS FOR ADOPTION

A resolution ordering and calling a special election to be held in the City of Westwego, State of Louisiana, to authorize the renewal of a special tax therein; making application to the State Bond Commission in connection therewith; and providing for other matters in connection therewith.

Offered by Council Member Green:

A resolution authorizing Mayor Joe Peoples, on behalf of the City of Westwego, to enter into a Cooperative Endeavor Agreement with the State of Louisiana, for the allocation of Seventy Five Thousand Dollars (\$75,000.00) of state funds to the City of Westwego for river shuttle services from the Westwego River Landing or improvements to Sala Avenue.

Offered by Council Member Green:

A resolution authorizing Mayor Joe Peoples, on behalf of the City of Westwego, to enter into a Cooperative Endeavor Agreement with the State of Louisiana, for the allocation of Two Hundred Fifty Thousand Dollars (\$250,000.00) of state funds for the Jefferson Performing Arts Society – City of Westwego.
