Mayor Billiot entertained a motion to have the City Attorney look into the matter of emails and data of the previous administration.


MOVED by Council Member Utley, and seconded by Council Member Valence, to have the City Attorney look into the matter of emails and data of the previous administration.

APPROVED. Yeas: Campbell, Nobles, Valence, Utley; Absent: Bonvillian


